Short's Travel Management's Booking System has been upgraded to continuously check flight costs for up to 24 hours after an itinerary is purchased. Effective February 1, 2013, the booking system will monitor flight costs to ensure that the University is paying the lowest possible airfares. This automated process for monitoring flight costs for possible airfare cost savings is a quick, continuous process. The service fee to book the new lower airfare will be \$24. The additional \$24 service fee will be charged only if there is a new airfare (within the 24 hour window) that is at least \$100 lower than the original airfare. This will ensure a savings at a minimum of \$76 per ticket when an airfare cost savings becomes available.

Whenever there is a lower airfare price for that same original itinerary, regardless if the airfare booking was issued on-line or with an agent, Short's Travel will void the original ticket and send a new invoice to the traveler with the new ticket information which includes the additional service fee of \$24. The payment of the original ticket price will be credited at the time the new ticket is processed. Based on the payment method, travelers and/or travel arrangers should expect to see the original airfare charge and original service fee \$5 or \$24, the credit of original airfare charge, the new airfare charge and the additional \$24 service fee on their personal credit card statements, LaCarte or CBA entries.
